Group B Members employed after 1/1/2022

### **Calculation Formula:**

Yrs of Service × Highest 36 mos. Avg Pay × 3.2%  
(Group A)

Yrs of Service × Highest 60 mos. Avg Pay × 2.5%  
(Group B)

### **Vesting:**

10 yrs of creditable service (Group A & B)

### **Retirement Eligibility:**

23 yrs of service at any age (Group A)

20 yrs of service at age 55 (Group A)

25 yrs of service at min. age of 50 (Group B)

Any yrs of service at Age 62 (Group A & B)

Proportionate Retirement counts toward  
eligibility, not benefit calculation

Purchased Military Service does not count toward  
eligibility, only toward benefit calculation

## **DROP**

### **Deferred Retirement Option Plan**

#### **Eligibility:**

Retro DROP: 23 yrs as of 4/1/2015

5-yr Forward DROP: 23 yrs as of 2/17/2016

7-yr Forward DROP: all members

## **PROP**

### **Post Retirement Option Plan:**

PROP Deferrals of \$250 or more

Two distributions allowed per year of at least  
\$2,500

All accounts on 12/31/2021 total \$30.3 million  
with 215 participants
