I. Call to Order and Roll Call

Chair Tyler Link called the meeting to order at 11:30 a.m. and roll call was taken.

II. Public Comment

IV. Consideration of Potential System Legislation for the 87<sup>th</sup> Legislature

Pursuant to the positions passed by the Board in September, an overview of draft legislation was provided by Executive Director Pattie Featherston, System legal counsel Chuck Campbell and Alyca Garrison, and System actuary Lewis Ward.

Motion by Tyler Link to adopt the proposed legislation as presented. Motion seconded by Thomas Hugonnett.

Motion amended by Ed Van Eenoo to instead direct the Executive Director to present the draft legislation to the joint City/APRS working group, seek feedback and report back to the February 17 APRS Board meeting for possible action. Motion seconded by Kathie Tovo. Motion as amended failed.

The original motion by Tyler Link, seconded by Thomas Hugonnett, passed.

V. Consideration of a Budget Amendment to the 2021 System Administrative Budget Related to Governmental Affairs

The Executive Director presented a budget amendment to increase the category of governmental affairs for a total of \$162,000 in order to provide increased assistance during the 87<sup>th</sup> Legislature.

Motion by Tyler Link to adopt the budget amendment as presented. Motion seconded by Keith Harrison. Motion passed.

VI. Executive Director Report

The Executive Director provided an update about selection of a new benefit software and vendor, the annual conflicts of interest confirmations, training opportunities, and an upcoming study by the actuary related to the cost of purchased permissive service credit.
